## PROPERTY TAXES DUE BEFORE FEBRUARY 1, 2012 TO AVOID PENALTIES AND INTEREST

EDINBURG, TX – Hidalgo County Tax Assessor-Collector Armando Barrera reminds all property owners that property taxes must be paid in full by the deadline of January 31 to avoid penalties and interest. Property taxes for the year 2011 become delinquent on February 1, 2012.

Residents can pay their property tax in person at one of six office locations, but are advised that there may be a lengthy delay to process payment due to the high volume of traffic at the offices. Property owners can choose to pay online at [https://actweb.acttax.com/act\\_webdev/hidalgo/index.jsp](https://actweb.acttax.com/act_webdev/hidalgo/index.jsp) for a small convenience fee. Payments are also accepted at all First National Bank locations in Hidalgo County. Residents' current tax statements are required to make payments.
