## PROPERTY TAXES DUE BEFORE FEBRUARY 1, 2014 TO AVOID PENALTIES AND INTEREST

**EDINBURG, TX** – Hidalgo County Tax Assessor-Collector Pablo (Paul) Villarreal, Jr. reminds all Hidalgo County property owners that property taxes must be paid in full by the deadline of January 31 to avoid penalties and interest. Property taxes for the year 2013 become delinquent on February 1, 2014.

Residents can pay their property tax in person at one of six office locations located throughout the County, but are cautioned to expect delays to process payment due to the high volume of traffic at the offices. **The main office in Edinburg will be open from 8 am to 7 pm on Friday, January 31, 2014 to accommodate taxpayers prior to the deadline.**

Property owners can choose to pay online at [www.hidalgocountytax.org](http://www.hidalgocountytax.org). Payments are also accepted at all Lone Star National Bank locations in Hidalgo County; residents' current tax statements are required to make payments at the bank locations.

If you own any type of property in Hidalgo County but have not received a statement, please call the Hidalgo County Tax Office at (956) 318-2157. Failure to receive a statement does not affect the validity of the tax, penalty or interest, or due date.
