HIDALGO COUNTY TAX OFFICE PUBLIC NOTICE TO ALL TAXPAYERS

EDINBURG – Hidalgo County Tax Assessor – Collector Pablo “Paul” Villarreal Jr., urges County residents to pay their outstanding property taxes if they haven’t already. According to Villarreal, pursuant to Section 33.07 of the Property Tax Code, all 2013 taxes, penalty and interest that remain unpaid as of July 1, 2014, will incur an additional 15 to 20 percent in attorney fees, depending upon the policy adopted by each respective taxing jurisdiction, to help defray the cost of collections.

To avoid paying the additional attorney fees, residents must pay their 2013 taxes before July 1, 2014. If County residents own property and have not received a statement, they are instructed to call the Hidalgo County Tax Office immediately. Failure to receive a statement does not affect the validity of penalties and interest, nor attorney fees.
