AS PROPERTY TAXES DEADLINE APPROACHES, TAX ASSESSOR/COLLECTOR ELIMINATES FEE FOR ON-LINE PAYMENTS

EDINBURG – Hidalgo County Tax Assessor/Collector Pablo “Paul” Villarreal Jr. announced Friday that a convenience fee for on-line e-check payments made through the county’s website will no longer be charged. Taxes are due by Saturday, Jan. 31.

Previously, homeowners were required to pay a 2.5% convenience fee for every \$100 owed. Effective immediately, that fee is now waived when residents pay their taxes online with an e-check. This permanent change only applies to property tax payments.

Property Tax payments are due by Saturday, Jan. 31. Since the due date is on the weekend, the Tax Office will accept payments on Monday, Feb. 2, providing residents with a two day grace period.

Hidalgo County residents may also pay their 2014 taxes at all Lone Star National Bank branches located in Hidalgo County. The original, light green statement is required when paying at Lone Star National Bank.

Property owners are responsible for their 2014 taxes, whether or not they have received a statement. If you own property in Hidalgo County and have not received a statement, call or visit any of the following locations from 8 a.m. to 5 p.m. Monday through Friday.
