Hidalgo County Pct. 1 Office hosts Delta Area Tax Office – Justices of the Peace Substation Open House

ELSA – Hidalgo County Precinct 1 Office will host an open house celebration in honor of the grand opening of its Delta Area Tax Office – Justices of the Peace Substation, on Tuesday, Aug. 11 at 10 a.m.

The newly remodeled facility will be open from 8 a.m. to 5 p.m. Monday through Friday. In addition to the tax and motor vehicle services, Justice of the Peace Precinct 1, Place 1 Gilberto Saenz and Justice of the Peace Precinct 1, Place 2 Jesus E. Morales offices will allow residents to pay their fees and fines in Elsa, rather than drive to their Weslaco offices.

Delta Area residents located in La Villa, Edcouch, Monte Alto, Hargill and the northern parts of Weslaco, Donna, Mercedes and surrounding Precinct 1 communities will find the Elsa location to be more convenient. Precinct 1 Commissioner A.C. Cuellar Jr. said the new facility will relieve the busy Weslaco Substation and reduce traffic and wait times.

"We are strongly committed to expanding county services in this area," said Cuellar. "We have been working on this project since 2013 and, on August 11, we will be able to better serve our Delta area residents with their own substation."

The remodeling cost an estimated \$50,000. Much of the repairs were conducted by Hidalgo County Facilities Management workers which helped reduce the cost.
