



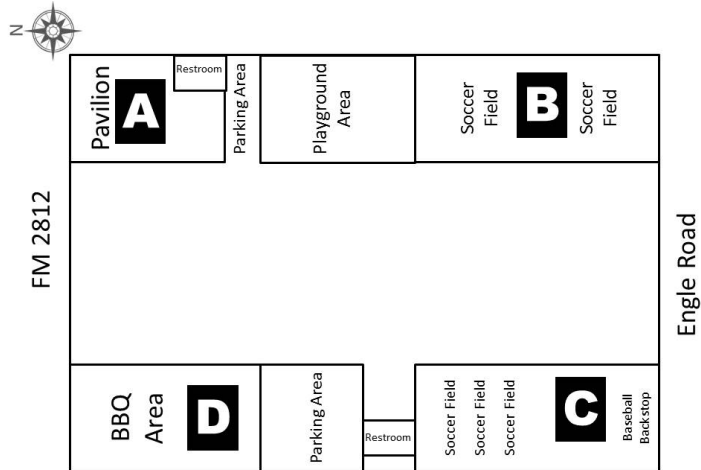

HIDALGO COUNTY PRECINCT 4: PARK RESERVATION FORM
RULES AND GUIDELINES:

The Parks of Hidalgo County Precinct 4 are available for use by the constituents of Hidalgo County, Community related groups and other governmental entities and general public. These rules and guidelines for utilizing Hidalgo County Precinct 4 parks are subject to change, and include, but are not limited to the following;

1. Scheduling for use of the Park will be done through the office of the Hidalgo County Commissioner Pct. 4. If there is a County Pct. 4 or other County event scheduled on any of the days of operation, you may be required to cancel your event and reschedule on a later date. All County events take precedence over any other scheduled events. The County serves multiple organizations and communities and will do its best to accommodate constituents on a first come first serve basis. No regular periodic meetings will be scheduled.
2. The use by any organization shall not imply that the County and/or County Pct. 4, either directly or indirectly, believes in or subscribes to the philosophy of that organization.
3. Groups shall not exceed the occupancy load for any given area, as posted.
4. The group reserving the Park must not be affiliated with profit-making or partisan political sponsorship, must not be organized for the benefit of private individuals and must not charge admission to the program/function.
5. The County and County Pct. 4 are not responsible for any damage, loss, theft or disappearance of property or for injury to persons in connection with the use of the premises or equipment. Each group/person using the Park shall be liable for any damage caused to the property or contents.
6. User will be responsible for returning the reserved Park area to the same condition as it was found including appropriate clean-up and restoration of chairs/tables/equipment to their original configuration.
7. User will be responsible for disposing and hauling their trash.
8. No pets (except service animals), bicycles, roller blades, and skate-boards allowed.
9. No firearms, weapons, illegal drugs or alcoholic beverages allowed.
10. Smoking is prohibited in accordance with County policy.
11. No amplified music such as DJs, bands, or loud radios.
12. No serving of food or beverages without prior approval from a Pct. 4 Authorized Supervisor.
13. The reserved Park area must be completely vacant by the function end time in order to accommodate the next function scheduled. No event and/or activity shall continue past 8:00 p.m.
14. Failure to abide by these rules may affect future ability to reserve Park. Use of the Park which in the judgment of the Pct. 4 County Commissioner could cause damage to County property or disruption of the daily office operations shall not be permitted. The Pct. 4 County Commissioner retains the right to deny the space to any user whose planned use of the space does not comply with these terms.
15. The Pct. 4 County Commissioner shall have the authority to promulgate additional rules and regulations.
