Seven more deaths related to COVID-19 reported in Hidalgo County along with 177 new positive cases

EDINBURG - Officials with the Hidalgo County Health and Human Services Department reported seven more deaths related to COVID-19 on Wednesday and 177 new known positive cases, Hidalgo County Judge Richard F. Cortez said Thursday.

"The country is seeing record numbers of new cases," Judge Cortez said. "We must prepare for that by being extra careful among crowds and by wearing facial coverings in public. I extend my condolences to the family and friends of those who died and my prayers to those who are sick."
