I affirm that I am a U.S. citizen, 18 years old or older, Texas resident, have not been finally convicted of a felony or, if a felon, fully discharged of sentence, including any term of incarceration, parole, supervision, completed period of probation, or have been pardoned (*Texas Election Code, §13.031(d)*). A person is *not considered to have been fully convicted of an offense if the person's adjudication of guilt was deferred (HB 1226, 82nd leg.)*.

I have not been determined by a final judgment of a court exercising probate jurisdiction to be totally mentally incapacitated or partially mentally incapacitated without the right to vote (*Texas Election Code, § 13.031*). I further affirm that I have not been finally convicted of an identity theft offense (*Texas Penal Code, § 32.51*).

I acknowledge I am responsible for complying with all volunteer deputy voter registrar rules as stated in the Texas election code and outlined in the Volunteer Deputy Voter Registrar Information Manual 2017-2018 and that my failure to do so can result in appointment termination and/or criminal consequences.

The appointment terminates on the person's final conviction for an offense for failure to deliver a registration application and may terminate on the registrar's determination that the person failed to adequately review a registration application (*Texas elec. Code, § 13.036 (2)(b)*). Further, an appointment terminates on a person's final conviction for an offense of performance-based compensation for voter registration activities (*Texas elec. Code, § 13.008*) and/or final conviction for an identity theft offense (*Texas penal code, § 32.51*).
