**ISSUING ORDER AND NOTICE OF
CITY RUN-OFF ELECTION**

WHEREAS, I MARIO GARZA, in my capacity as Mayor of the City of San Juan, Texas do hereby order that a City Run-Off Election be held in said City on the 12th day of JUNE, 2021 that being the SECOND SATURDAY of said Month; and

WHEREAS, The terms of office for Mayor Place 1, Commissioner Place 2 and Commissioner Place 3 will expire on the 12TH day of June, 2021 and it is necessary to conduct a Run-Off Election for the following Officers of said City:

**OFFICE OF MAYOR- PLACE #1
OFFICE OF CITY COMMISSIONER -PLACE #2
OFFICE OF CITY COMMISSIONER -PLACE #3**

**IT IS THEREFORE, ORDERED BY THE CITY COMMISSION OF THE
CITY OF SAN JUAN THAT:**

Section 1. Call of Election; Date; Eligible Electors; A Run-Off election (the “Election”) shall be held on Saturday, June 12, 2021, at which all residents, qualified electors of the City shall be entitled to vote.

Section 2. Election Day Polling Places; Voting Precincts. Except as otherwise provided herein, the polling place for each voting precinct and the voting precincts for said Election and the boundaries thereof are as follows:

**Voting Place One - Fire Station No. 2 - Election Precincts 39, 59, 117
 2301 N. Raul Longoria and 245
 San Juan, Texas 78589**

**Voting Place Two San Juan Memorial Library Election Precincts 4, 156, 118
 Multipurpose Room 137 and 178
 1010 S Standard
 San Juan, Texas 78589**

That the Board of Commissioners of said City will appoint by resolution the Presiding Judges and Alternate Judges of each of the polling places for said Election pursuant to Section 32.001 of the Texas Election Code.

Section 3. Election Day and Early Voting Day, dates, hours, and polling place: Early voting shall commence and terminate as required by state law. **The polling**

places for Early Voting by Personal Appearance will be at San Juan Memorial Library Multipurpose Room, 1010 S Standard, San Juan, Texas 78589. Early voting shall be conducted in accordance with the Texas Election Code on the following days, dates, and hours during the early voting period:


