RESOLUTION ISSUE IN
ORDER AND NOTICE OF
MUNICIPAL ELECTION.
DATE OF ELECTION IS
November 8, 2022.

WHERE AS, Vernon's Texas Civil Statutes, Texas Election Law, prescribe that the Mayor of the governing body shall order Municipal Elections and notice of said election be given in accordance with said laws and;

WHERE AS, THE CITY COUNCIL HAS ON TWO SEPARATE OCCASIONS REQUESTED PUBLIC INPUT REGARDING A PROPOSED CHARTER AMENDMENT OF ARTICLE NO. 3, SECTION 2, BE AMENDED TO CHANGE THE TWO YEAR TERM OF OFFICE FOR MAYOR AND ALDERMEN TO FOUR YEAR TERM.

WHERE AS, THE CITY COUNCIL HAS APPROVED FOR THIS CHARTER AMENDMENT TO BE PLACED ON THE NOVEMBER 8, 2022 CITY ELECTION.

WHERE AS, THE CITY COUNCIL HAS ON TWO SEPARATE OCCASION REQUESTED PUBLIC INPUT REGARDING A CHARTER AMENDMENT OF ARTICLE NO. 3, SECTION 6, BE AMENDED TO INCLUDE A FILING FEE OF \$1,500.00 OR AN ALTERNATIVE PROCEDURE FOR PAYMENT OF FEE FOR THE OFFICE OF MAYOR AND THE ALDERMEN.

WHERE AS, THE CITY COUNCIL HAS APPROVED FOR THIS CHARTER AMENDMENT TO BE PLACED ON THE NOVEMBER 8, 2022 CITY ELECTION.

THEREFORE, EDCOUCH CITY COUNCIL HAS APPROVED THE PLACING IN THE NOVEMBER ELECTION BALLOT TWO MEASURES FOR CONSIDERATION BY THE CITIZENS OF EDCOUCH THESE TWO CHARTER AMENDMENTS.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF ALDERMAN OF THE CITY OF EDCOUCH, TEXAS, THAT:

1. The Honorable Mayor of the City of Edcouch, Texas by virtue of the power vested in him by law does hereby, Order, that an election be held in the City of Edcouch, Texas, on November 8, 2022, being the Second Tuesday, of said month for the purpose of amending the City of Edcouch Charter with the above mentioned.
2. That the Board of Alderman have determined that said Elections shall be in said City in the following wards to wit:

Precinct #16 — SGT Rodriguez Community Center

3. That early voting (absentee) shall be conducted at SGT Rodriguez Community Center. Early voting by personal appearance shall be by voting machines and Early voting by mail shall be by paper ballot. The presiding Judge of the Absentee Ballot Board shall submit separate returns of the absentee votes.
4. The Mayor of the City of Edcouch shall give NOTICE of said Election, and this Ordinance of Order of Notice of Election shall serve as Notice of said Election at three designated public places, which said notice shall be posted at least twenty (20) days before the date of the Election.
5. That on Election Day the polls shall be opened from 7:00 A.M. to 7:00 P.M. and the method of voting shall be by voting machines. Immediately after the votes have been counted, the Election Officers shall deliver returns of said election in replicates. One copy being delivered to the Mayor of the City of Edcouch, one being retained by the Presiding Judge, and one copy with election supplies, being delivered to the City Secretary as provided by the Election Code.
6. That the Board of Aldermen will meet on Thursday, November 17, 2022, at 6:00 pm for the purpose of officially canvassing the Election Returns, and declaring the results.



WHERE AS, the terms of office of Alderman Place 1 Rene Adan Flores, Alderman Place 2 Joel Segura, and Alderman Place 5 Lorenzo Cabrera of the City of Edcouch, will expire the first Tuesday, November 8, 2022.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF ALDERMAN OF THE CITY OF EDCOUCH, TEXAS, THAT:

1. The Honorable, Mayor of the City of Edcouch, Texas by virtue of the power vested in him by law does hereby, Order, that an election be held in the City of Edcouch, Texas, on November 8, 2022, being the Second Tuesday, of said month for the purpose of electing the following officers: ***Alderman Place 1, Alderman Place 2, and Alderman Place 5.***
2. All requests by candidates to have their names placed upon the ballot for the above-mentioned election shall be in writing and signed by the candidate, such request to be filled no later than ***5:00 pm on August 22, 2022.*** All candidates for city office may file for office beginning ***July 23, 2022, at 8:00am at City of Edcouch, with the City Election officer.***
3. That the Board of Alderman have determined that said Election shall be in said City in the following wards to wit:
Precinct #16 — SGT Rodriguez Community Center
4. That early voting (absentee) shall be conducted at SGT Rodriguez Community Center. Early voting by personal appearance shall be by voting machines and Early voting by mail shall be by paper ballot. The presiding Judge of the Absentee Ballot Board shall submit separate returns of the absentee votes.
