RESOLUTION ORDERING THE ELECTION ON NOVEMBER 8, 2022, FOR DONNA INDEPENDENT SCHOOL DISTRICT AT-LARGE POSITIONS 5, 6, AND 7 AND AUTHORITY TO NEGOTIATE AND EXECUTE AN AGREEMENT WITH THE HIDALGO COUNTY ELECTIONS DEPARTMENT TO CONDUCT THE ELECTION.

The DISD Board of Trustees is required to order an election to be held within the geographic boundaries of the Donna Independent School District (DISD) on November 8, 2022, for the purpose of electing a trustee for the following at large positions:

- At large position 5, currently held by David De Los Rios; term expires November, 2022
- At large position 6, currently held by Lt. Col. (Ret) Roberto Perez; term expires November, 2022
- At large position 7, currently held by Maricela Valdez; term expires November, 2022

In accordance with the Texas Election Code, Sections 3.004-.005, the resolution ordering the election of DISD Board of Trustees must be made at least 78 days prior to the trustee election, in addition, the election order is submitted in English and Spanish, and the notice is posted in designated places required by law.

The documents used to order the election will be forwarded to the DISD Board of Trustees under a separate document.

This agenda item also seeks authorization for the superintendent of schools or a designee to negotiate and execute an agreement with Hidalgo County to conduct joint elections for the above referenced DISD at-large trustee positions.
