**Zero deaths related to COVID-19 reported in Hidalgo County along with 430 newly reported positive cases.**

**As of December 1st, DSHS has shifted to updating their COVID-19 dashboard from twice a week to once a week (every Wednesday). Hidalgo County will continue reporting twice a week.**

Hidalgo County uses the case status definition provided by the Texas Department of State Health Service's 2022 Epi Case Criteria Guide revised May 2022.

1. *Confirmed: A person who has tested positive through a molecular test (PCR) that looks for the virus's genetic material.*
2. *Probable: A person who has either tested positive through an antigen test or has a combination of symptoms and a known exposure to someone with COVID-19 without a more likely diagnosis.*
3. *Fatality: Deaths for which COVID-19 is listed as a direct cause of death on the death certificate. A medical certifier, usually a doctor, determines the cause(s) of death. Deaths of people who had COVID-19 but died of an unrelated cause are not included.*
