1. I have the right to dispute the allegations and request a court hearing if I so desire, and, if so, no further effort at Deferred Prosecution will be made. I also understand that no information obtained from me or my family while participating in Deferred Prosecution will be used against us in any future Court Hearing.
2. I understand that I will be on Deferred Prosecution by agreement with the Hidalgo County Juvenile Department for a period not to exceed
 SIX MONTHS TWELVE MONTHS
3. I understand that I make this agreement voluntarily and can withdraw from the agreement at any time
4. I understand that this Deferred Prosecution Agreement does not constitute an adjudication of delinquent conduct or conduct indicating a need for supervision.
5. I agree to Pay restitution:
 - a. In the amount of \$_____ Payable at the rate of \$_____ per month.
 - b. **Payments will be made payable TO: HIDALGO COUNTY JUVENILE PROBATION DEPARTMENT**, by Money Order or Cashier's Check, only.
 - c. To be made through the office of **LITA L. LEO, HIDALGO COUNTY TREASURER**, at 2810 South Business Hwy. 281, Edinburg, TX 78539.
6. While on Deferred Prosecution, I will obey the following conditions:
 - a. I will remain in court ordered custody/placement.
 - b. I will obey all federal, state, and city laws.
 - c. I will refrain from possession or use of any illegal or harmful substances/contraband/weapons.
 - d. I will avoid anyone on adult probation, juvenile probation or parole except in immediate family.
 - e. I will report to my Probation Officer as DIRECTED and call if unable to report.
 - f. I will attend every school class regularly and obey any/all school rules and regulations. No tardies or absences and maintain passing grades. If not enrolled in school, obtain a general education development certificate (GED).
 - g. I will remain in Hidalgo County unless advance permission from the Court has been obtained
 - h. I will maintain the following curfew: 7:00 P.M. HOME RESTRICTION
 except when in the custody of the child's parent, or subject to school, church and work exceptions, for the term of deferred.
 - i. I will notify the Juvenile Department immediately of any change of address and/or telephone number.
 - j. I will attend any/all scheduled counseling appointments as directed by juvenile probation and participate with ordered counseling sessions.
 - k. I will attend Deferred Prosecution Orientation when scheduled;
 - l. I will submit to drug screening as directed by the juvenile probation, at any given time and location.
 - m. I will refrain from any contact with the victim or their family, and any co-defendants.
 - n. I will comply with Community Service Restitution, if applicable.
 - o. I will appear with parent before the court as directed, for a status hearing
 - p. **I will not go within 200 yards from the alleged victim.**
 - q. **I will not go within 200 yards where the alleged victim resides or attends school.**
 - r. **I will not communicate directly or indirectly in any threatening manner towards the alleged victim, her family or members of her house hold.**
 - s. **I will not engage in any conduct that will alarm, torment, abuse or embarrass the alleged victim.**
 - t. **I will attend sex offender treatment as ordered by this Court.**
 - u. I will participate in a psychological evaluation.
